

## **WHAT CAN I PUT IN THE MIXED NON-HAZARDOUS WASTE SKIP?** Please read and understand before signing

Skips are for general and inert waste such as soil, garden waste, paper, plastics, wood, old furniture etc. Any waste on the list below cannot be placed in a general waste skip. If you do produce any of the following waste please call 028 3086 0550 to arrange a quotation or to ask for advice.

### **PLACING ANY OF THE ABOVE ITEMS IN A GENERAL WASTE SKIP WILL INCUR ADDITIONAL CHARGES**

The Company shall not be liable for any damages to surfaces, manholes, walls or property caused by company vehicles or equipment while on the hirers premises and the hirer will at all times keep the Company indemnified in respect of a claim by a third party for loss, damage or expense of any nature or description resulting as aforesaid.

### **T&C's**

This contract for the provision of waste equipment and waste related services, the hire of items and accessories, plant, to the hirer, the contracting party, as detailed in the quotation or order record. These terms and conditions shall apply to the hire of the equipment and plant between Skips R Us Limited and the hirer. The parties to the contract are the hirer and Skips R Us Limited whose registered offices at 132a Concession Road, Crossmaglen, Newry, BT359JE.

#### **1. General**

1.1. Any order placed with Skips R Us Limited which takes its vehicles off the public highway will be at the customer's own risk. They will accept full responsibility for any consequential damage that may occur to persons, property or vehicles as a result of this.

1.2 Skips R Us Limited shall not be liable for any loss or damage caused by failure to supply or any delay in supply which may be caused directly or indirectly by any circumstances beyond our control, including act of God, fire, accident, breakdown of machinery, shortage of labour or materials, or by any act of neglect on the part of the customer.

1.3 Skips R Us reserves the right to charge the customer for all costs incurred as a result of the cancellation or variation of the whole or a substantial part of an order, together with loss of profit and all other consequential loss.

## **2. Skip Hire**

2.1 Asbestos, fridge freezers, televisions/monitors, tyres, fluorescent/sodium lamps, gas cylinders or any waste deemed as hazardous by an absolute or mirror entry in the European Waste Catalogue (Article 1(4) of the Hazardous Waste Directive 91/689/EC) must not be placed in the skip container unless by prior written agreement with the company.

2.2 It is the responsibility of the hirer to ensure that skips placed on the highway or public places have the permission of the local highway authority and are adequately lit and coned off in accordance with The Roads (Northern Ireland) Order 1993. Skips R Us Limited can organise a consent to deposit a builders skip or permit at an additional cost to the hirer.

2.3 The hirer shall ensure that the skip is not overloaded by weight or by volume at the point of collection. Skips should be loaded so that they are filled no higher than the fill level as indicated on the side of the skip. Skips are only to be used for light waste or loaded no more than the maximum legal road limit for the vehicles. Skips R Us Limited reserves the right to refuse to collect overloaded skips and any costs incurred due to unsafe loads/overloading (including wasted journeys) will be passed on to the hirer. Additional charges may be levied.

2.4 The stated hire charge on the order are for the duration of the contract and includes Saturdays, Sundays and public holidays. Hire charges include carriage and delivery unless otherwise stated. A maximum of 30 minutes attendance by the delivery vehicle at the address specified by the hirer. The hirer will pay for any further time at £ 45 stg/hour or euro equivalent. Abortive carriage charges may be levied when delivery or collection has not been possible when undertaken in accordance with the hirers instructions. Where an approved credit card or debit card transaction has taken place and subsequent payment shortfalls arise, such as unsuitable waste, overloaded skips, or overdue returns, Skips R Us Limited may process for payment for balance due. Similarly Skips R Us Limited may process part payment at interim stages of the contract. Once an order has been placed a minimum cancellation period of 24 hours is required, where 24 hours notice of cancellation is not given, Skips R Us Limited reserve the right to charge full costs as originally agreed with no refunds. No negotiations will be entered into.

### **OVERLOADING WILL ALWAYS INCUR EXCESS CHARGES**

2.5 The lighting of fires in or near skips is strictly prohibited. The hirer will be liable for any loss or damage to the skip container (excluding fair wear and tear) during the term of the skip hire period and will be charged the current purchase price for the skip. Once a skip has been placed, it shall not be repositioned without prior consent from Skips R Us Limited. Moving skips onsite could result in inability to collect the skip.

2.6 The maximum rental period is 7 days for "cash" customers and 28 days for "Account" customers. It is the responsibility of the hirer to request the collection within this time. Failure to do so will result in an unannounced collection and/or rental charges being incurred of £ 75 per week for Roll On-Offs and £ 25 per week for 4, 8, 12 & 16 yard skips or the euro equivalent.

2.7 The responsibility of the skip remains with the hirer until collected by a Skips R Us vehicle. Any skips which are removed whilst in the control of the hirer will be charged at full replacement value.

2.8 The hirer shall not lift waste skips by crane or any other means. Dedicated certified crane skips available upon request.

2.9 The hirer shall allow access to the equipment or the plant at all reasonable times for the purpose of inspection, maintenance, collection, replacement or reposition.

2.10 Should any of these terms be held to be invalid, such invalidation will not affect the validity of the remaining terms and conditions.

### **3. Payment Terms**

3.1 Payment terms for authorised credit customers are 14 days net from the date of the invoice, in accordance with the Late Payment of Commercial Debts Interest Act 1998, Skips R Us Limited reserves the right to charge interest on late payment of commercial debt at base rate plus 8%. The hirer will pay all monies outstanding, on demand including penalties and interest on amounts overdue and will be liable for reasonable legal charges incurred by Skips R Us Limited in the recovery of the equipment, the plant or the amount due.

3.2 Non account holders: Prior to or on delivery of skip. The owner accepts major credit and debit cards, cash and bankers drafts.

3.3 Refund Policy – More than 3 days notice – 10% of total hire charge. 1 – 3 days notice – 50% of total hire charge. Less than 24 hours notice – 100% of total hire charge.
